MCPSEF's primary program services consist of providing direct financial support to students and educators through scholarships, awards to graduating seniors, and grantmaking activities. In the spring of 2025, the organization awarded \$1.9 million in scholarships and awards to 198 students across 14 scholarship and award programs. Of these, 170 students received MCPSEF's largest scholarship (in recipients), a four-year scholarship totaling \$10,000 per recipient, established in honor of Ruth and Norman Rales and former Montgomery County Board of Education member Patricia Baier O'Neill.

During the same period, MCPSEF distributed \$1.15 million in grants to the MCPS. MCPSEF's grants program includes 51 educator grants of \$5,000
